

PRIVACY POLICY

This privacy policy ("Policy") describes how (Life Your Way) (Unit 8 , 102 Nicholson Street, Greenslopes QLD 4120) (<https://www.livinglifeyourway.net/>) (+61 413 180183) ("Company," "we," "us" and "our", "controller") processes, collects, uses and shares personal data when using this website (Life Your Way Web Site link), (the "Site"). Consent
